The members agree that the organization and summoning of the meeting has been conducted according to the charter.

The agenda is determined and agreed on.

Erik presents the Treasurer's report:

- 2020-2021 has been different from an economic standpoint. In Hilary last year we had two sittnings and a drinks event and the ambassadors' dinner (organized by the previous committee). In Trinity there were no events, and in Michaelmas there was one walk event with very little expenses
- Overall profit is £956.73, which is very big. However, the Ambassadors' Dinner, which the next committee will organise next year, will have £730 budgeted for that, which will come straight from this year's profit. Last year's committee had expected in their budgeting for the event to have been organised by this committee, but instead the next committee will organize it next year.
- Committee members have been Bianca, Erik, Elias, Rosma, Meri, Robin, Theodora and Alex. We have met online regularly on Sundays. Has been nice.
- Budget: for 2020 it was not met for obvious reasons. We made income in activities (as they were all low-cost for us) and have made profit in memberships and sponsorships.

- We sold 600 pounds of sweaters (24pcs). Very happy about this last time we sold stash it sold a lot less, but now we made £400 of profit on them.
- We did not have sponsorships this year.
- The website was slightly cheaper this year than expected.
- For next year's budget: lots of uncertainty. Hopefully a sittning in Michaelmas or an outdoor sittning in Trinity, and we've budgeted some money for that. We've budgeted more money for next year, as we made lots of profit this year. Also, some money is budgeted for songbooks, but no for sponsorships or sweaters planned for at this point. £250 for the website and £50 for other things. Overall, a £650 loss for 2021-2022, which should be accounted for by this year's immense profit.

Q: Why are the events next year more expensive for Scansoc?

• Erik: We want to make up for people having bought so many memberships with basically no real events this past year. So, when events are held next year, the committee should put effort and money into them. Also, since we made so much profit now, we can afford having more expensive events next year to remain non-profit.

Marieke presents the Auditors report:

- As auditor, my responsibility is to review the committee's year and finances. I found that finances have been handled responsibly and have no inconsistencies or errors to them. There is consistent agreement between accounts and treasurer's reports, the accounting is detailed and well-structured, and the treasurer has been very open and accommodating in helping me do my work. I recommend that the general meeting accepts the treasurer's report and grants freedom of liability for the committee.
- COVID-19 note: this past year it has not been possible to organize usual events, but the Society has continued to organise its activity well despite the past year's situations. The pandemic is expected to continue to affect the society's events, which the treasurer's report has accounted for.

The meeting grants the freedom of liability for the 2020-2021 committee.

Motions for the board:

• No motions have been received by the committee ahead of the two-week time period.

Elections

President

Hello! I'm Rosma. 2nd year chemist at St Anne's College: I'm Finnish but also • international. I've been in charge of the email and helping with the Instagram account. I've run and planned events. Thank you for committee, it's been a fantastic year. When I was thinking about what to say, I thought of last year's AGM. The past year has been unexpected, but the important thing is that we have our community and our Scandinavian traditions. Q: Alcohol? Should we focus on alcoholic or nonalcoholic events?

Robin: We can't be too boozy - have to take it easier. Sittnings and drinks events have alcohol, but we'll have to see what people like and what people want to do and plan accordingly.

Q: Are you ready to work and not just drink at events?

Robin: I can drink on my own time, but Scansoc is for business.

Rosma: I can't wait to get back to work in events and not drink but work.

Robin is elected as vice-president

Treasurer

Erik runs as the only candidate.

• I've been treasurer for a year, last year I ran on the basis of making scansoc a pyramid scheme. Now, my plan is to take payment as only songbooks. but I will consult the committee before making decisions on that.

Q: Do you propose paying V&A with songbooks for sittning rent?

• If they are up for it, yes. We can also develop a Scansoc bitcoin.
