Summary

This is the treasurer's report for Oxford Scandinavian Society for the period from the 1st of January 2020 to the 31st of December 2020, to be presented at the annual general meeting on the 3rd of March 2020.

As the treasurer of the society, my main responsibilities has been the treasuries of the society. This is divided into long-term and short-term tasks. The long-term task is the keep the budget of the society in balance and make sure that we have enough liquidity to run the activities. The sort-term task is to keep accounts of all incomes and expenses. These accounts have been given to the auditor for review.

In 2020, the society made a profit of £956.73. This was driven by the postponement of the 2021 ambassadors dinner, for which a £700 loss was planned to be accounted for in 2020, but will now fall on the 2021 budget.
